- The Top 3 Scratch Series at the End of Game 5 Automatically Advance to the Stepladder Finals seeded in that order.
- The 4th spot will be determined at the End of Game 6 with total pins carrying over into that 6th Game.
- The 5th spot will be determined at the End of Game 7 with total pins carrying over into that 7th Game.

3. \$10 Survival Pot Games 1-5
 - 5 Game Survival Pot. If 30 people get in
1st \$100, 2nd \$80, 3rd \$60, 4th \$40, 5th \$20

Oil Pattern Similar to the US Open Pattern
May not play exactly the same on our lane surface*

RULES:

1. Qualifying Round: 5-7 Games moving pairs each game. Left Lane moves Left, Right Lane Moves Right.
2. Stepladder Finals immediately following the Qualifying round. 5 Bowlers will compete in the Stepladder Finals.
3. The Top 3 Scratch Series at the End of Game 5 Automatically Advance to the Stepladder Finals.
4. The 4th spot will be determined at the End of Game 6 with total pins carrying over into that 6th Game.
5. The 5th spot will be determined at the End of Game 7 with total pins carrying over into that 7th Game.
6. Any PBA Member who has an Exempt Status with the PBA is not eligible to bowl.
7. Prizes: Must Have 6 Bowlers to Guarantee 1 FREE Entry into the U.S. Open. Pay-Out Same Day of Tournament.
 - a. Prize List on the Front of Flyer is based on Last Year's 42 bowlers at a 1 in 4 Cashing Ratio
 - b. Cash and Prize List will go up or down depending on amount of Pre-Paid and Walk-In Entries
 - c. The Bowler that wins a FREE Entry is responsible for their own transportation to the US Open. If they do not participate in the U.S. Open, they forfeit any money that was paid as the entry fee for the U.S. Open Event.
 - d. Bowlers may not substitute U.S. Open Entry for Cash. If they choose not to accept the Free Entry, It will be awarded to the next place.
8. This tournament is open to any bowler who is certified under the USBC or pays the USBC participation fee.
9. The U.S. Open Tournament itself is conducted in accordance with the general playing rules of the Professional Bowling Association. Bowlers are responsible to read the U.S. Open Tournament Rules and be eligible to participate in that event.
10. The Tournament Director reserves the right to reject any entry prior to bowling.
11. Once the tournament begins, no refunds will be given for any reason.
12. ALL USBC Rules Apply. All Decisions made final by the Tournament Director. All Pay-Outs are Final once paid out.
13. **Tournament Entry Fee:** Pre-Pay or Make a Reservation ON or BEFORE Saturday Jan. 22, 2011 = **\$100 Per Person**, Walk In the Day of Tournament = **\$120 Per Person**.
14. **Side Pots Extra:** 5 Game High Game Pot \$20, 5 Game Survival \$10, and \$5 Brackets for Game Sets 1-3 & 3-5
